1. We, attorneys of Dr. Koba, have received an official action rejecting subject application for the following reason from the Japanese Patent Office:

Reason for Rejection

The invention of this application is recognized to be such that it could have easily been accomplished on the basis of the invention described in the following publications circulated within Japan prior to the application by any person having common knowledge in the technical field to which such invention belongs, and, therefore, to be ineligible for patent in accordance with the provisions of Article 29, para. 2 of the Patent Law:

2. Our Comments

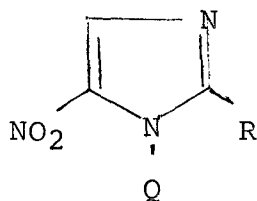


We are enclosing a copy each of the citations together with our English translation of pertinent passages of citations (5) and (6).
